The company may request a list of who is authorised to accept a delivery.</p> <p>A certificate signed by a Member of Ayber Bottle CC shall be prima facie proof of the existence of an indebtedness of the customer to Ayber Bottle CC.</p> <p>The customer is obliged to notify the company of any change of ownership within 7 days thereof.</p> <p>No variation of this contract shall be binding unless reduced to writing and signed by both parties.</p> <p>The customer confirms that the information herein is true and correct and that Ayber Bottle CC may make any enquiries for credit approval of whatsoever nature at any time.</p> <p>The customer agrees to pay interest at the rate laid down by the Prescribed Rate of Interest Act at the date in question, and only in respect of such amounts that are overdue, owing and payable.</p> <p>The customer consents to the jurisdiction of the Magistrates Court for recovery of amounts due in terms of Section 28 and Section 45 of the Magistrates Court Act of 1944.</p> <p>The customer agrees that in the event of it becoming necessary for Ayber Bottle CC to institute action for recovery of any amounts due to it, the customer will be liable for all costs incurred on the scale as between attorney and client, including collection commission of 10% per instalment, tracing fees, and other disbursements.</p> <p>The customer chooses domicilium citandi et executandi at the street address referred to above.</p>
